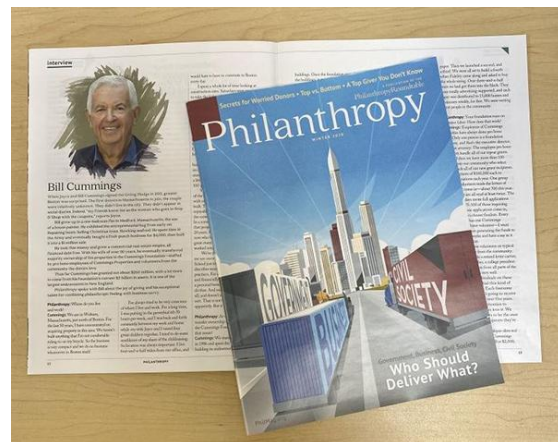

## Friendly Reminder

**Important Parking Reminder:** Most parking spaces immediately adjacent to Cummings Center buildings are designated for short-term use only. These short-term spaces are expected to turn over frequently so as to provide convenient building access to visitors and patrons of the more than 600 on-site businesses. Short-term spaces are identified by signage and are monitored throughout the day. **Reminder/violation stickers will be placed on vehicles parked for extended periods, and repeat violators will be towed at the expense of the vehicle owner.**
