## Campus Update

**New Construction Coming:** Cummings Center patrons may have noticed increased activity in the south parking lot between Route 62, East Garage, and the Marblehead Bank/People's United Bank ATM building. Cummings Properties donated those two acres of land to Beverly in 2001 for the construction of a public safety building. Now, some 19 years later, the city is mobilizing toward construction of a three-story, more than 30,000-square-foot, state-of-the-art police station. Soon, construction fencing will be installed surrounding the entire construction zone, and the east entrance to Cummings Center from Route 62 (i.e., the entrance closest to the MBTA tracks) will be closed. Going forward, that entrance will be used for construction vehicles, and then for police business only. It is anticipated that the new facility will be fully operational in mid to late 2021.
