**Fowl Play:** Please don't feed the birds. A growing population of geese, ducks, and, occasionally, two great blue herons, has made Cummings Center "home," perhaps due to a seemingly unlimited supply of food from well-intentioned people. Although the birds may be cute and fun to watch, feeding them can actually be harmful to their health and can also attract unwanted pests and vermin.

[Massachusetts Division of Fisheries and Wildlife](#) warns that feeding birds encourages them to stay in one place and build up flocks that a habitat cannot support. For these reasons, it is very much in the

birds' best interest for people to stop feeding them.
