## **Friendly Reminder**

To help maintain an attractive, professional environment, please remove all non-COVID-related paper signage from outside or near client suites. Cummings' written consent is required prior to placing any sign, advertisement, notice, lettering, or other object outside client suites or on or near the glass of any window, door, partition, or wall visible to the exterior of client suites. This long-standing policy prohibits similarly placed paper signage altogether.

With the health of the community foremost in our minds, we will continue to make an exception for COVID-related notices, but we will return to enforcing our paper signage prohibition.

Fun facts about the historic Cummings Center site, formerly known as "The Shoe"

During its operation from 1905 to 1987, The Shoe was Beverly's largest business. The smokestack was an identifying feature of the compound, due to its bold lettering and central location. After a few years of disuse, the mortar deteriorated, and the smokestack became structurally unsound. As a result, it needed to be removed. During the construction of Cummings Center, Bill Cummings' wife, Joyce, had the bittersweet and distinct honor of pressing the button that demolished the smokestack.
