





New Safety Legislation: Effective **February 25**, *An Act Requiring the Hands-Free Use of Mobile Telephones While Driving* will take effect in Massachusetts. The new legislation will prohibit individuals from engaging in the following activities while driving a motor vehicle: holding a mobile phone or other electronic device; viewing text, images, or video on said device; and operating
